RESOLUTION: NOTICE OF ELECTION

DATE OF APPROVAL: November 3RD, 2025

BE IT RESOLVED by the Board of Fire Commissioners of the Deer Park Fire District of the Town of Babylon, County of Suffolk, and State of New York as follows:

SECTION #1: that the Annual Election of the qualified voters of the Deer Park Fire District shall be held at the Deer Park Fire Headquarters at 94 Lake Avenue, Deer Park, New York 11729 in the Town of Babylon, County of Suffolk on Tuesday, the 9th day of December, 2025 between the hours of 6:00 pm and 9:00 pm for the purpose of electing one (1) fire commissioner whose term of office shall be for a five (5) year period commencing on January 1st, 2026 and expiring on December 31st, 2030.

SECTION #2: that the Notice of said Annual Election shall be as attached and published in Newsday on Thursday, November 6, 2025.

SECTION #3: prospective candidates must file a petition duly notarized with twenty-five (25) registered voters of the Deer Park Fire District with the Fire District Secretary at the Deer Park Fire District Office no later than Wednesday, November 19th, 2025 at 3:00 pm - (said time being twenty (20) days before said election) during fire district office hours of 9:00 am until 2:00 pm. Said petitions are available for pickup at the Deer Park Fire District Office at 94 Lake Avenue, Deer Park, NY Monday through Friday beginning on Friday, November 7th, 2025.

SECTION #4: that the vote will be carried out and only residents registered with the County Board of Elections and residing within the fire district for thirty (30) days prior to the election are qualified to vote for fire district commissioner. In 2025 the last date you will be eligible to register to vote with the County Board of Elections is Monday, November 17th, 2025.

SECTION #5: that any fire district commissioner must, at the time of his election and throughout his term of office, be a legal resident of the Deer Park Fire District.
